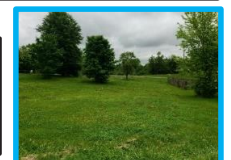

Manager's Report by Rob Clarkson



The end of the boating season is quickly approaching and with a lot of help we can put another safe year behind us. Refresh yourself with the Boating Rules. We operate in a counterclockwise direction, yield right of way to smaller crafts, and only operate non-motorized water toys in the No-Wake areas. No-Wake areas are clearly marked with buoys 75' from shorelines and at the entrance to No-Wake coves or at the No-Wake portion of a cove. Orange flags are required when towing Skiers, Tubes, Knee Boards and all other occupied water toys. This is a state law.

We have had some buoys moved around the lake and I would like to emphasize that buoys are placed in areas for safety reasons. Do not drag them off to other areas of the lake. Sometimes the tackle breaks that anchors our buoys and the buoy itself floats off, however this hasn't been the case as of late.

Maintenance is busy repairing our roadways in preparation for resurfacing with Oil and Trap Rock. We are stockpiling Trap rock below Su Twan Dam so parking is limited at that location temporarily. Please give plenty room and use caution on the roadway when you encounter them. Speed limit within our community is 25MPH.

Volunteers are always needed for our many committees. Our community relies on volunteers for many of the activities throughout the year and without your help these activities cannot continue to be successful. We have had a group step up and take over the Social Committee this year and they have put on a few events which were accepted well within our community. Currently they have a Golf Scramble and Kayak tour scheduled for September 4th. Come join in the fun and support your community volunteers raise money for new playground equipment.

Clubhouse Boat Dock Repair/New Bumpers

Robert Wittkamp The bumpers that I thought I was going to be able to get are not available right now. So when they come available, he will give them to me, but it could be six months, two years we don't know. So it was an access thing, and they just don't have them right now. **Jerry Allen** Did Rob ever look into what it would cost us for these bumpers. Do you know, Angie? **Angie Webster** I do not.

Robert Wittkamp I believe he was waiting on me to come back. **John Crotty** Would we like Rob to go ahead and research that as the docks will probably get more use as the restaurant does open. **Jerry Allen** Definitely, I think we need to get a number about what it's going to cost us to repair those. **John Crotty** I will communicate that to Rob. And thank you, Bob, for looking into that.

Variance Request – Storage Shed (1676)

John Crotty We had a variance from the last meeting for 1676. It was for a storage shed that's already in place and was a little close to the road. We'd asked them to get signatures from their neighbors agreeing that the shed can stay as it is built and the board does have a letter that was sent to the neighbors and was signed by five of the neighbors, agreeing that the shed can stay where it's at. Variance Request – Fence (468)

John Crotty The request is to install a fence with one-inch boards between which will give them 16 1/2 percent visibility versus the 33% required. There are pictures in your packet detailing what the other neighbor's fences look like and what this fence is going to look like. The reason for this is the neighbors have dogs and so do they and they're trying to give a little more blockage between the dogs and reduce barking and noise pollution in the neighborhood. The building committee does recommend this and thinks it's a nice looking cedar fence. **Bob Yungck (468)** I am the owner and the reason for the fence basically is not privacy, it's courtesy. The neighbors behind me have some large dogs. My daughter who's going to purchase the house when I sell it to her has some large dogs. My son on the opposite side has a small dog and the other people behind us have a couple real small dogs who like to bark. And I look at this as a courtesy, so we don't have a lot of noise complaints. It will be professionally made. It's nothing that's going to be privacy, there is wind to come through. And I went out and I have neighbor's signatures today that approved and signed it and dated. So I have copies if you all would like that. **John Crotty** Yes, we would want to put a copy of that in your file.

Variance Request – Culvert (468)

John Crotty Variance request to eliminate the culvert into the driveway or install a six-inch plastic. As you can see in the picture of the driveway, the crown in the road, if the culvert is installed at 12 inches it will not drain properly, water will pond in the yard. The building committee does recommend this variance. As long as the owner agrees to purchase a culvert when ditching is done and lowers that area. **Ty Van Ryswyk** Again, I know this project. It makes sense to accept it in the fact that if he digs in a culvert, he's digging a hole on his yard to hold water.

John Crotty I do have a little bit of an update on the restaurant. They are having some difficulties getting their liquor license through the state of Illinois due to some zoning changes is my understanding. They do have a date that they're potentially meeting with the state or county of August 12. So their hope is they will get their liquor license on August 12 and be able to open shortly after that. What they're asking of the board is, since we did have in our contract with their first month of rent due August 1, and they will not be open by August 1, would we be willing to postpone that first rent by a month. There's a chance that if they don't get their liquor license August 12 they may be coming back to ask for another month. But this point, they're just asking for August to be deferred. **Jerry Allen** I have no problem with that at all.

Ty Van Ryswyk Makes a motion to differ of the first month's rent to September.

John Crotty We will notify them they will not have to be pay rent on August 1. And right now the contract will start September 1 for rent. Let's hope everything goes well so we can get the restaurant open for some of the summer.

Correspondence

Mooring Post Request

John Crotty Letter from Scott Hodges (1711). He is requesting that we add a post to the no wake area of the ski beach outlot so he can tie his boat up there. **Jerry**

Allen I think we talked at the last meeting about putting posts on some of our outlets and then we thought the best route to take instead of just putting posts up was to get some input from the membership and also have them ask for us to do that for them in certain spots. So I would be willing to agree to put this post in for this particular member. **Robert Wittkamp** But it would be open right. So they wouldn't actually have no claim to it. **Jerry Allen** Correct. **John Crotty** So if someone else parked there they will probably ask for another post. **John Crotty** Do we want to limit amount of spots? Do we do that? **Shaun Diltz** There's none there right now. I agree with what we've said that we should have somebody meet him there and discuss this spot. And if the employee of Holiday Shores doesn't feel it's a good place, then we would need to discuss it. But as far as meeting and getting somebody out there, yes. I think we should look at the spot and put it in if it's accepted. Rob Clarkson can meet with him and give his recommendation to us at the next BOD meeting. **Jerry Allen** But obviously with him understanding that he leaves somebody else can park on that on that post.

Open Floor

John Crotty There's a lot of questions about what happened with the firework show. Our vendor for the pyrotechnics did have a technical issue. Specifically, they bought a new control board, and the electronic battery went out on the control board after the first set of fireworks went off. They did attempt to hotwire using a drill battery, that's how we got a few of the other ones that shot off, as you saw. And when it ultimately was done, they couldn't get the electronics to work, and they had to manually light the fuses. And that's why they all went off at the end, so everyone that watched it, the big final was everything left at once. They are obviously very apologetic; we've used them for a number of years. This is our first technical issue we've had with them, and they are offering a \$4,000 credit for next year's show. So we can either use that for more fireworks or get a discount on our what we normally budget. Obviously, next year the board can make a decision on whether or not we want to bid out a little more and see what others offer. But they

obviously do realize they made a mistake and did not make as good a show as we'd like. **Robert Wittkamp** What was our budget this year? **Shaun Diltz** \$16,000 **Angie Webster** And that amount has not increased in the 18 years that I've been here. **John Crotty** There were some concerns that because it hasn't increased that we've seen a little bit shorter of a show each year. **Roger Rawson (1851)** I know the problems you guys go through on the board, and I want to thank you for your time. The fireworks as far as I know, the budget has been \$16,000. I've been here 22 years. And when I first got here the show was over an hour. Last year, it was 14 minutes. This year, it was 8. And this is not the first technical glitch these guys have had. They had a glitch here before or the year before that where we had pauses and intermittent fireworks. So you guys need to discuss what you're going to do about it, because we're down to a few minutes of fireworks. Do we need to have a special assessment for an increase in fireworks? Do we want to try to increase the dues you know, are you gonna just let it whittle away at a budget of \$16,000 and in a few years it'll be down to less than 10 minutes? Of course, this year was eight minutes with a technical glitch. Last year was 14. Of course, when you pay the same amount you're going to get less and less each year. So I brought this up back earlier this year and I know you got some new board members and wanted to make you aware that it's been \$16,000 for a long time, couple decades. **Shaun Diltz** You are right, this isn't the first technical glitch. It was probably five years ago when, by the time I parked the boat in the back of fishing cove, the rest of the finale went off. So there was about a 20-minute delay. And there was little hiccups last year too, so you're not wrong. **Roger Rawson (1851)** So I don't know what your thoughts are on either increasing the fireworks or, you know, you guys got any ideas or thoughts? **John Crotty** Well, I think it is worth looking at others, and maybe getting a better idea what they promised us for that money for timing or whether it is the amount of fireworks. Then we can compare and see if it's more or less for that same price. **Robert Wittkamp** Maybe if we do this, we put some stipulation in the contract that if you fail in any way, then there's a substantial deduction automatically for that. If we're paying for 30 minutes of a show, I expect 30 minutes of a show. I don't know what the parameters are that's why I'm saying we need to know what we're actually paying for. **Shaun Diltz** We're paying for booms, each individual firework. **Roger Rawson (1851)** Yeah, I mean, just, you know, you look at the the setup they had, the amount of mortars they had set up was very small compared to what I've seen, you know, in the last four or five years. It's definitely getting smaller. **Jerry Allen** I think it'd be a good idea for us to get bids this coming year, since we've had a couple of technical issues, the past four or five, to see what other companies can provide to us? We may have to pay more but if we get a better show longer show I think it would be worth it. **Ty Van Ryswyk** We're talking about two different things. One, they had an issue this year, and they're trying to refund us some money and that's appreciated, I would think. I think that's a good thing. But what's being discussed right now is no one's fault other than we've been paying the same amount. You can get bids, but you're still going to get \$16,000. So I think what he's asking, and it can't be discussed right now in 10 minutes, but do we want to raise that dollar amount when we go to get bids? Or do we want to say, put on a 30-minute show or we want 10 more booms than last year? I think this is a full-blown discussion that needs to be had. **Roger Rawson (1851)** For the contract, I'd say it'd be a timed event and then how many booms do we get for the time, and then they'll give you a budget of what that's going to cost and, and you're going to have to present it to the to the membership, because it's definitely going to go up significantly. I think even if the show and gone good, it'd probably been about 12 to 10 minutes, because like I say, last year was 14. **Shaun Diltz** Alright, let's say it's been steady for 20 years, if we would have just added two and a half percent inflation, to this line item on our budget, we'd be at \$26,000. today. **Dave Decker (1184)** If you're going to go out to bids, you better do it now. Because if you're doing it on the Fourth of July, there's only so many people out there that can do it. And you're going to have to book them early. So if you're planning on doing that, you better start now. Different topic, you're seeing all the new stop signs popping up like mushrooms. And I know that one of the ones that was talked about was four way stops on Tampico and Nassau. Was that part of what was actually approved? Because I don't know what the final approval was. **Jerry Allen** Not on Nassau and Tampico. There was supposed to be two stop signs, both of them are on Tartaruga at Barbados and then the yield signs were turned from yield to stops

was supposed to be a stop sign at Caribbean, I'm not sure if it's Key Largo or Key West there. And I think there was a couple other stop signs on Fountainbleu.

Dave Decker (1184) I just wanted to make sure that if that was being turned into a four way, I was going to ask you guys to reconsider. **Jerry Allen** No, that's not part of it. **Shawn Hagen (1991)** Just trying to figure out something here. We had the annual meeting here not too long ago, and I ran for the board. And I lost and I have no problem losing. I've lost a lot of things. But during the process, I met with John, I met with Tony and they told me that Dan Hopkins was going to be retiring off the board at some point and that's fine. And they said that I would be on the board. And again, I don't have any problem of Dan, not being here and I'm not there. What I do have a problem with I think, is that we've got a board member on the end, and no disrespect to you sir, but I don't think you got any votes at the annual meeting. And I was eight votes short of being up there with you guys. And again, I have no problem of not being up there. I do have a problem with the other 85 people that voted for me that wanted me up there with you guys. And I don't understand what happened. I would think that when Dan went off the board, and you guys said I was going to be there, somebody would have contacted me. I opened up the Holiday Times, I see that Dan is off the board. And I'm like, okay, I would think you guys would have contacted me. And then I see that you're on the board. And I don't understand that. Because I don't think it's right. When there's 85 people that voted for me. And again, I'm not being up here going put me on the board. I think it's wrong to ignore those 85 people's vote. So maybe you can tell me what happened. **John Crotty** The Board does bring forth anybody who was interested in the board at a board meeting after the board member has resigned. Because your self-serving versus looking out for what the people really said. That's my opinion. **Jim Hagarty (431)** I guess you heard about our problem. If you don't mind, can I pass you these pictures down? Since they opened up the waterways on Tamarach I've been taking on a lot of water, I mean a lot. This is in my garage last year, and that's like an eight-inch drop. And across the street, where the fault drains into, it's been collapsed, and they just keep throwing riprap in it and that's not going to fix the problem. **Ed Luedde (445)** I'm on the Tamarack side, it's like a huge river that flows, I get it from both sides and from across the street and it flows right by my house, it was all the way up to my fence. It was all the way by my tree and all my water runs in his yard and makes a huge lake in front of his yard. **Jim Hagarty (431)** I'm taking water from Tamarack, 2 sides of Tamarack and the culvert going across the road, I believe it is a 12". And it's collapsed on the other side of the road. **Shaun Diltz** And this is going from across Tamarack to the lake. **Jim Hagarty (431)** Yes. **Ed Luedde (445)** I just moved in in September last year and this is how it's always been when it rains heavy. I got a constant river. It goes in my backyard as well. I got videos that I did put on the Holiday Shores Facebook page on messenger. And I don't know if you guys saw that or anything, but someone saw it and they said to just email them, I think it was someone who's coming back on Monday. But I'm gonna email, I got videos and pictures. His house is also included. You can see the lake that's out there, It's pretty bad. Every time it rains it's just a river about this wide. And it just flows, and it just gets bigger and bigger and bigger. And it goes to his backyard and goes by his garage, all his yard all the way to the front. **Jerry Allen** I did drive by your house and to see that because Anthony Harrell must have visited with you. **Ed Luedde (445)** I gave him a call and he actually came out to my house. **Jerry Allen** And it was remarkable how much water, I didn't see the water. All the different paths of the water to your house, it's amazing. You got like six or seven coming in there. **John Crotty** We did get this yesterday, from Anthony after the big rain on Monday. Rob and Rob aren't here tonight, Rob Clarkson is on vacation. We would like as a board to talk with them and get them at our next meeting and give us an update kind of where it's at. Where that was in the process if they knew. Honestly, I think Rob Frey knew that it floods, that's why they were putting riprap in front of it, and we'll help come up with a plan. We just need to reach out with Rob and Rob for more

information. We're going to get Rob all this information and Rob will take a look at it and bring it to the board, and we'll talk about what the resolution will be. And you had made the comment that you wanted to see if there was any interest in that board position. So my question is, how did you make that known to the membership out here that somebody had resigned, to see if there was any interest in that position? Because I didn't see anything in any of the minutes. The thing that I saw was Dan wasn't present at a couple meetings. And then there was the meeting where, oh, we have a new position and this guy, let's vote him in, but I don't know, was anything made known to the membership out here, that there was a board position available? **Linda Thus (6)** I know I read through the minutes. I don't recall seeing it. **John Crotty** It would have been April 28 when Dan resigned. **Linda Thus (6)** And are you saying it's in the minutes that are published in the Holiday Times that he resigned? **John Crotty** Yes. **Linda Thus (6)** Okay. I don't recall seeing that. **John Crotty** He resigned officially and that was the meeting that he officially resigned, and we would have made the announcement at that meeting that he was no longer a member, and that the board would be looking to appoint a member until the next annual meeting. **Linda Thus (6)** Okay, and so it was definitely in the May minutes. 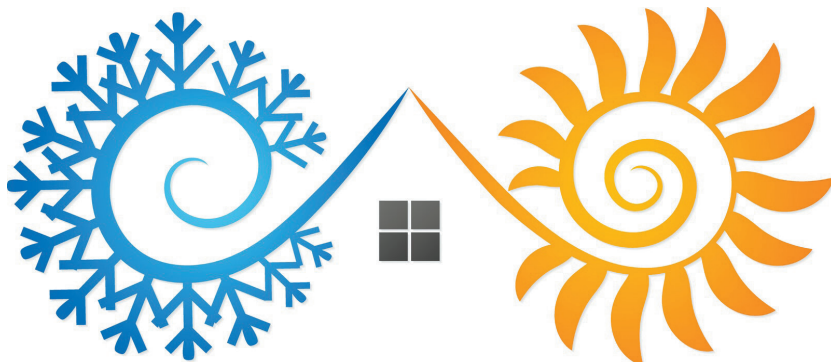

may vote for two people. So the people who mailed in their ballots or brought their ballots in and had already voted, didn't get the opportunity to vote for a third person, which would make it unfair, you'd have to change it. **Shawn Hagen (1991)** Why would it make it unfair if there's three positions and three people. **Angie Webster** Right, but the ballot stated that you could only vote for two. **Shawn Hagen (1991)** Again, logic doesn't prevail here, guys. **Jan Nelson (1608)** Okay, we have a problem with the water. The cul de sac is coming down and hitting into the, I think they're like 12-inch drains. And we're getting water from the fields behind us. I have pictures too. So it's coming down, I have a river in my yard. But in order for the water to go through the drain, it has to go over the road. In other words, it's not open on my side, it's open on the road side. So it's going over so it has to go fast enough to get over it to drain. And then once it stops that fast, then it just sits in my yard until it goes into the ground. I'm up on a hill sorta, the road is so all that water goes down there and then the cul de sac is higher up and it goes down. So it hits the drainage coming so fast that her drain across the street, 1610. It's so fast that it's going into her yard down into the into the lake, she's on the lake. Most of the time they're 24 going across the road. **Marian Zorich (1610)** It's bad because I get it from everybody. And I also get it from the other side because I'm on the point out there and erosion is all over the place. John Crotty I sent you a text message and you had a common courtesy of responding if you have an issue with sizes of the stop signs, bring it up to the meeting. Well, I corrected you all on that, didn't even get a thank you or anything for that. No problem. I understand. Got that. Silt removal, do we have a silt removal plan for the lake? **John Crotty** We currently do not, no we're working on it. **Matt Ressler** Working on it? I mean, we've been working on this for what, how long? A year or 2? A year at least. The silts not getting better, guys. It's three feet deep out there in the back of some of these coves. I mean, we need to get a plan, we need to get moving on it. We've been talking to the lake manager for over a year and a half about this and we've got nothing that, as normal from the lake manager. **John Crotty** I would disagree. **Shaun Diltz** Ressler, you have a lot more than nothing. One thing that he did do last year, was he took three days, and pulled 4000 cubic yards out of the back of Spanish cove to give the board a better idea on how much it would cost in future plans. So yes, 100% we definitely need to get a plan together. **John Crotty** That cost was approved by the board. We also are looking at any potential grants that we can get for that. **Matt Ressler (2064)** So where are we at with grants? I mean, we want to talk about grants. **John Crotty** We've been applying for grants, and we've not gotten any in that we've been trying for. We have also recently begun looking at what we can get for the current equipment for silt issues that is not working and coming up with a plan and price for reserves for what will be working. So we are working on it. **Matt Ressler (2064)** I think just letting the membership know that you guys are actually working on it would be helpful. **John Crotty** That's fair enough. **Matt Ressler (2064)** I mean, because as of right now, you know, nobody knows anything. But you guys, I mean, why not put it out to the membership and let us know, hey, we're working on these things. We're trying to put a plan together. I understand we did the back of Spanish Cove, but we need to be doing something in-house internally. You know, to remove it ourselves, we can do that. Doesn't take much. But anyway, another issue. I got a citation or a letter, whatever in the mail for tall grass, it was like a four-foot area. I'm kind of worried about it because our lake manager let me rephrase this. I drove to the community this evening, took some pictures and actually I texted them to you and Jerry Allen. Did you guys just get them here since the meetings started. **Jerry Allen** I've had my phone off so I didn't. **Matt Ressler (2064)** Okay, well, here's a perfect example of a few things if you would, I would ask you to please pull those pictures up that I just texted you guys. And you'll see that very first one that is located at 603 Westview. I drove the area of Westview and Clover this evening before I came here, took these pictures, send them to you guys. Was there any citations issued on these yet, in the last 90 days? I'll go back 90 days. Because the way Angie read it this evening, there were six citations in the last

month. **John Crotty** Yes, that's correct. **Matt Ressler (2064)** I would like to know if there were citations especially issued on 603 because that's the lake manager's house. When you look at that picture, how can he send anybody a citation out here for anything when he don't even have his own house in order? How is that? Explain that to me, John would you. **John Crotty** I cannot. **Matt Ressler (2064)** Why not? Why can you not explain that to me? **John Crotty** Because I just got the picture two minutes ago and I don't even know if that is his house. **Matt Ressler (2064)** So let's look at another picture that I sent you. If you go down through here, you're gonna see there's an Association lot. Did we or did we not pay maintenance extra when I was on the board last year to clean up these properties? Our own properties? Right here's a picture, this evening of 617. You guys ain't even got your own house in order how can you guys write other people tickets or citations? Or even just send out courtesy letters or whatever? How can you when you don't have your own house in order? You want to explain that to me and the other membership out here? **John Crotty** I believe you were asking us while you're on the board to start writing more stuff. **Matt Ressler (2064)** But you wrote six citations in the last 30 days? Or sent out six letters? Hell, I drove down two streets and got 12 of them. You got them on your phone? Who's not doing their job? Is it the lake manager and the general manager? I mean, their salaries come out of my dues, right? And yours and everybody else's? If you're gonna write one ticket, you're gonna need to write them all the way across the board. Start with your lake manager. Who's gonna send him his citation for where he stays at? Are you gonna do it since you're the board president? **John Crotty** Sure. **Matt Ressler (2064)** You will. **John Crotty** If there's an issue, we will confront it. Yes. For anybody. But again, I just got these. You can't bring something to us one minute from the board meeting and expect us to answer it. **Matt Ressler (2064)** But it's okay for everybody else to get these but not him. **John Crotty** I do not agree. **Shaun Diltz** That's a rhetorical question you know that. Don't text us two minutes before the meeting, and then come and attack with an agenda. **Matt Ressler (2064)** I got an agenda. I got an agenda right here. It's called accountability and there is no accountability being held with the lake manager or the general manager or public safety. I mean, for God's sakes, I had kids driving around out here over the weekend. Kids hanging their feet dangling in front of the boat, public safety drives right past them. Wait a minute, let me rephrase that. They don't drive, they idle right past them, they don't know what full speed is. It's a safety issue. And then, you know, we're gonna talk about other citations. How many golf cart citations have been issued out here this year? **John Crotty** I do not have that data in front of me, I do not know. **Matt Ressler (2064)** Aren't you guys supposed to be getting that data? I know when I was on the board, they were supposed to give you all that information every month. **John Crotty** Still don't have that in front of me right here so I can't answer that question. **Matt Ressler (2064)** I think it's all about accountability at the end of the day. And I feel you guys as a board, need to start holding your office people and your upper management here accountable to move this community forward and get it cleaned up. Because it ain't happening. It's not happening at all. If you guys look past the tip of your nose you'll be able to see it out there. If you don't want to make people mad go sell ice cream boys. It's all I got. **John Crotty** Thank you for the feedback. **Shawn Hagen (1991)** Guys, I have a request that I think the rest of the community might also appreciate. When IDNR comes out here they use our boats correct? **Shaun Diltz** That's correct, most of time. **Shawn Hagen (1991)** Do they contact us prior to that, or do they just show up? **John Crotty** They, at some point, they have to know when the lake patrol will be out. So they will have to contact somebody. **Shawn Hagen (1991)** So when IDNR comes out on the lake and they contact our security and us, security that we pay for, could we get a notice through Facebook that IDNR is out here that we can spread around so that we can keep the rest of the community safe? Rather than I mean, if there's a police officer, parked somewhere down the street, we mass text everybody and says, hey, slow down. So why not have the same thing happen out here with IDNR, if they show up? I think the whole membership would appreciate either a text message, something on Facebook, whatever the way to get that out to the community, just to keep everybody safe. What do you think? **Jerry Allen** I think a lot of times IDNR comes out here and we don't know. I mean, they just show up unannounced. And they can wait for the boat, or they could get on the boat and take it out there. We may not have the time or the resources to put it on

Facebook that IDNR is out here. **Shawn Hagen (1991)** I can't imagine it taking a whole lot to go IDNR is on the lake. **Jerry Allen** I'm not on Facebook. **Shawn Hagen (1991)** I'm not either. **Angie Webster** Our Facebook in the office, the official site is not manned during the weekends. We do not update it on weekends at all. **Shawn Hagen (1991)** I'm hearing a bunch of excuses. But I think the membership will appreciate that. **John Crotty** Shawn, I think one of the meetings in the last few months, you've come up here and talked about lake safety. **Shawn Hagen (1991)** Yes, sir. **John Crotty** And that's the reason IDNR comes out here is to promote lake safety. So us telling people that they're going to be here, how is that going to help solve the problem. **Shawn Hagen (1991)** You're right. So if IDNR comes out, I would want to tell all my friends, hey, IDNR is out, make sure you have enough life vests, it's just a safety check. So by doing that, it not only protects us, it also protects the whole community. I think it would be a good idea. **Marian Zorich (1610)** I don't really know IDNR. But I if it's what that man told me, I don't think they should tell there going to be here. If they're drinking and other problems, it should be taken care of. **Shaun Diltz** So I was out of town up until about three hours ago, or I would have sent the email and done a little research on my own. I do believe the board last year, as far as research, I would have read the minutes and what was approved, Dave's here so he might be able to help. But the board last year approved graduation signage for I think 30 days after graduation or something to that effect. And I think it was just for last year and it was mostly because of the Covid thing. One, I don't think that got added this year, even though we were still kind of in Covid. Two, I thought it might be worth thinking about it. Just turning that into a rule as far as graduation signage in general. So nothing that I was going to motion today, I wanted to research what they passed last year and look at it moving forward. I've seen a handful of them out there and technically on the rules they're not allowed. I wouldn't want people grabbing them or anything. **Brok Chasteen (857)** You were talking earlier about grants and we keep getting denied. Why do we keep getting denied for lake grants? Is it because we're a private community **Jerry Allen** I think that has a lot to do with it. **Brok Chasteen (857)** So were private and can't get any funding from the state why do we have IDNR out here. **Jerry Allen** IDNR have control of all lakes in the state of Illinois. **Brok Chasteen (857)** If they can come out here and patrol I don't understand why they can't grant. So there's something in there and I'd just like a little more explanation than just they can do whatever they want. We're private, we have to approve anybody that comes into these meetings and anybody that comes on to this lake, but nobody knows when IDNR comes out here. They're just allowed to do whatever they want? **Jerry Allen** We are a Core of Engineer's lake and yes. **Brok Chasteen (857)** So then where's our grants? Why aren't we applying for them kind of grants. **Shaun Diltz** There were grants that we had gotten in the past as far as silt prevention when I was on the board the first time that I think the county was sponsoring us for, and that's what a lot of the work was done on the north end. There's baffles and silt ponds that have been dug and they've improved the water quality a lot. And I think there's been a few other watersheds that we've used that grant for and it's \$10-\$20,000, something like that. I don't know if we've gotten them in the past few years. **Brok Chasteen (857)** Well, that's kind of what I'm getting at, I think we need maybe to appoint somebody else, or all involved in trying to get these grants or letting us know what you're applying for. I mean, there's 1000s of them out there for this. Every other lake you go to they're getting, you know, Litchfield, for instance, just got a huge grant last year to dredge their whole lake. You know, I don't know exactly what it was, I don't know the ins and outs, I don't study it. But there's stuff out there. And every time you talk about it, we didn't get approved, we didn't get approved, you're not even telling us what we applied for or anything. And if they're coming out and patrolling it and we're paying taxes, why can't we get anything back and all I keep hearing is we're private, we're private, we're private. Well if we're private than they shouldn't even be on this lake. **Shaun Diltz** And that's something to discuss as far as letting them use our boats or not or making them bring their own. **Brok Chasteen (857)** If you don't allow them to use our boat, then they can't get onto our lake. They can patrol from the shoreline. **Shaun Diltz** No, they would bring their own boat. **Brok Chasteen (857)** How, we can't let them in, they don't have a key,

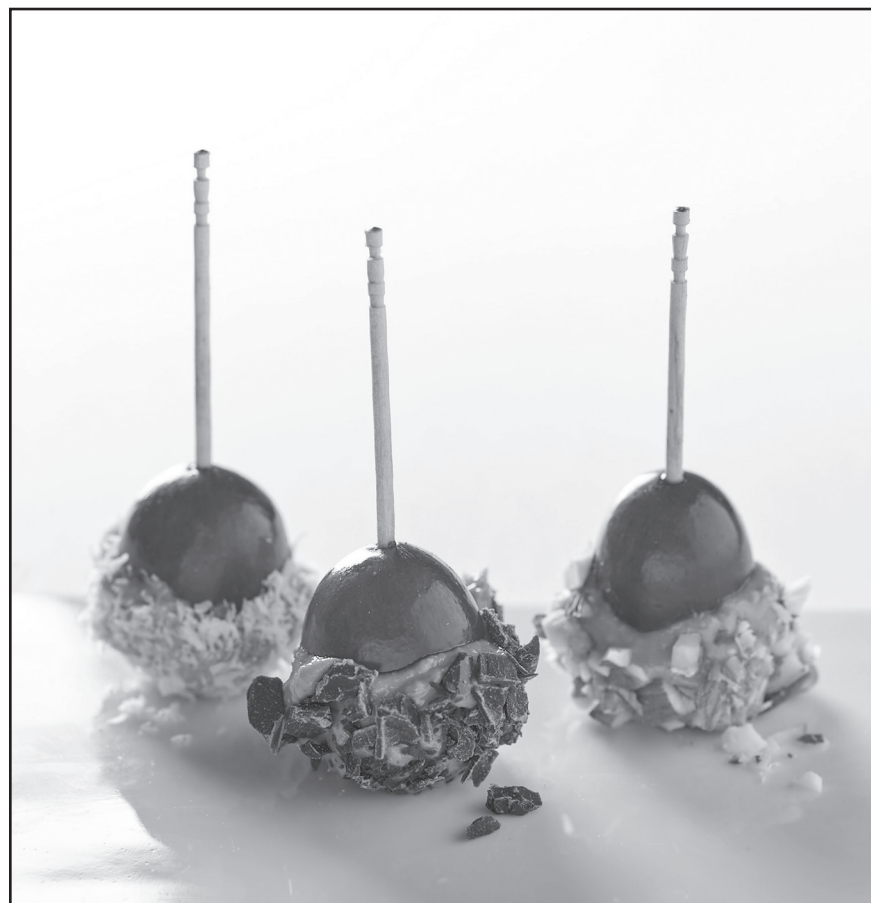

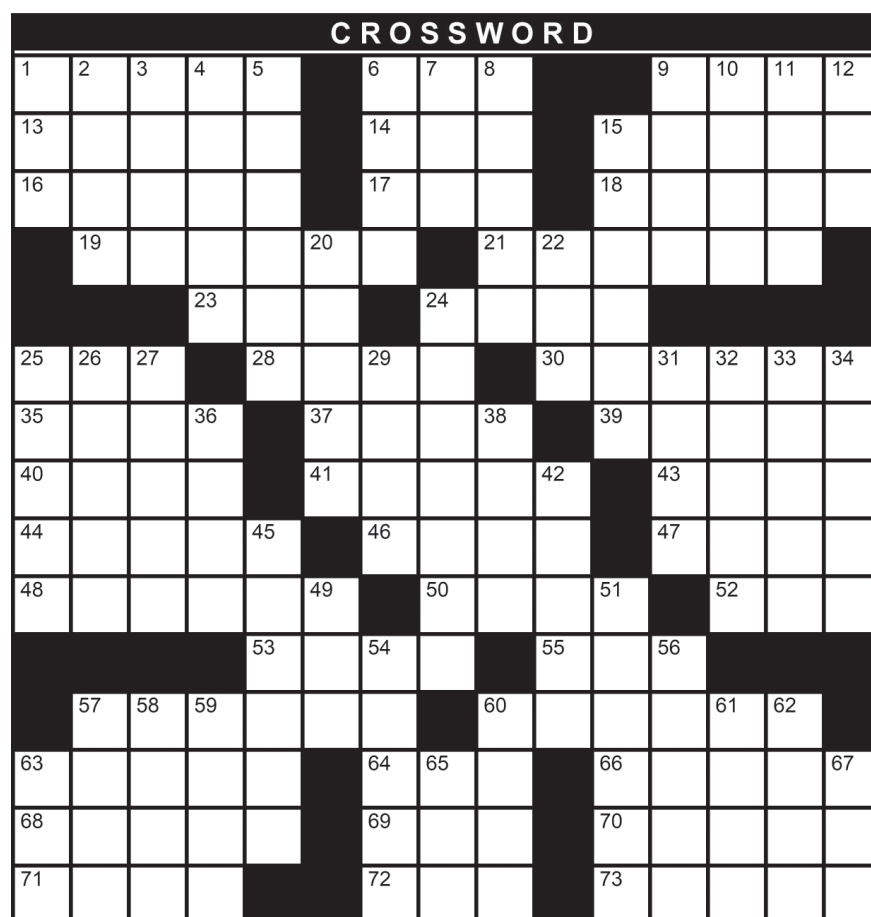

they're not a member. **Jerry Allen** You can't stop them. **John Crotty** It's the government and they were out here once this year with their own boat. And we asked them not to do that, to contact our public safety and be on our public safety's boat, not have their own boat on our lake. **Brok Chasteen (857)** Well why did you ask them that then? That's a decoy because we don't see them out there on your boat, on our boat. We think it's normal. **Shaun Diltz** I don't disagree. And I mean, but it is good to have a good relationship with them. They do shock our lake for the fish. **Brok Chasteen (857)** I get that, I really don't even care that they're out here. I just think if they're out here patrolling and writing our members tickets or doing whatever they're doing, then why aren't we getting any help from the state to keep our stuff up? So that's just kind of how I'm seeing about that. So if there's ways around this, or ways to get this into grants, that you know what I mean, that's just what I'm asking. Every time I come in here, I hear more and more about grants. And they're denied, and then we don't care anymore, and we talk about next year. You know, we all pay a lot of money in taxes, and we should receive some of it because we're never going to get any more dues because nobody's ever going to vote it through, so we need some more money out here. **Matt Ressler (2064)** I had a quick question about these boats, the kayaks. Are we even checking those out here also, you see a lot of people on kayaks with no stickers, no lot numbers, they ain't got life jackets. Another public safety issue, another accountability. **John Crotty** Yes, they should be checking those. **Matt Ressler (2064)** But they're not. Again, holding you accountable for this now, John. I'm not holding Rob and Rob accountable because we both know they're not doing their job so I'm gonna start addressing you with this. And everything else. **John Crotty** Ok. **Matt Ressler (2064)** You're the board president. I mean, who else do you go to? If you know they're not doing their jobs, you go to the board. Right. **John Crotty** Yep. **Matt Ressler (2064)** So what's your plan of action on everything that I brought you today? **John Crotty** Again, you brought them to us two minutes ago, so I do not have a plan of action. **Matt Ressler (2064)** Okay. So when will I see your plan of action? Can I get something in writing from you, an email, something? **John Crotty** We will at the next meeting, bring up any concerns that we're having with some of these items. **Matt Ressler (2064)** Okay. Sounds good. Thanks. **Shaun Diltz** And to address your kayak statement, in 2017 there was 123 non-motorized stickers issued. And we did address a lot of these kayaks and non-motorized boats that were not getting stickered, and this year, there's 483. So that's a 350% increase, so I would say that's been very successful. I know you're going to point out anecdotal stuff, but the data does show that the membership has listened and got a lot of the stickers for their non-motorized vehicles. **Jerry Theodore (1346)** I want to commend you folks for self-control, in conducting yourself so well. Some of the stuff you heard tonight was pure baloney. When I was on the board, I would not have had the restraint that you folks had. So I commend you. **Marian Zorich (1610)** Talking about the silt, are they ever gonna do anything with the silt in Su Twan? **Shaun Diltz** I think that should definitely be talked about in the silt extraction plan overall, because, yes, there's a lot of silt in those coves.

Anthony Harrell Motions to approve the minutes as amended.

**Mooring Post Request**

Letter from Scott Hodges (1711). He is requesting that we add a post to the no wake area of the ski beach outlot so he can tie his boat up there. **Rob Clarkson** We had one from a member up on the north side who wanted one behind the no wake buoy on the north end, which is the ski beach area. It doesn't prohibit the skiers from doing anything, it's all up behind that buoy. And when he showed me where he wanted it, it's actually closer to that first house which is a long way behind that buoy. I didn't have an issue with putting one there if you want. The second one is at the end of Castle, and he said as close to the dock as possible. Currently, there are none at either place. There's a dock at the end of Castle but there's no morning posts on either one of those outlots. **Shaun Diltz** So the one on Castle by the dock, how close are you going to put it to that dock. Because it kind of comes in a little bit, is there risk of the boat swinging and hitting the boats on the dock. **Rob Clarkson** We could put it 25 feet away if we want it. **Shaun Diltz** I didn't know where or I didn't know what you looked at and where you were going to go with it. So this is kind of a catch 22 for me as I want to provide areas for people that don't live on the lake to park their boat. But on the other side, there isn't very many fishing places to fish on this lake. Because, you know, everyone lives on it. And those two places are two of the, I would say main places that are decent to fish. The back of coves aren't good fishing, typically so that's why we can line those up with as many mooring posts as we could. If you put one in there and we end up lining a bunch up there, which may end up happening for as many people that live off the water. But I'm still thinking about the people that do fish in these areas too. I think we might be able to do some due diligence on some of the other outlets to see if we can't free up more space. But that's just my thoughts.

Jerry Allen On the area on Castle, to Shawn's point if somebody wanted to come down and fish off the dock and their walking down Castle to the water the docks on the right, correct. They can fish right off the end correct. **Rob Clarkson** Yes. One morning post isn't going to make a big difference on the fishing but like you said, future. **Shaun Diltz** I mean, even in the back of Spanish Cove, I've sat there with my girls and fished. And we just end up pulling catfish in between two boats, which, you know, it is what it is. I don't want to damage anybody's property either, that we're doing that with, but it does make it a little difficult for casting and stuff, especially with children. **Jerry Allen** Well I'm in favor or putting in the morning posts in both locations.

Jerry Allen Makes a motion to install the morning posts that the locations that you visited with the first member on the north end up by ski beach and also on the area on Castle that you believe is the best spot for it.

Ty Van Ryswyk Seconds

Ty Van Ryswyk In agreement with Shaun, I'm more familiar with the north end of the lake obviously and I wouldn't want that homeowner or all the boats turning at the north end of the lake to cause havoc for a bunch of boats lined up and take fishing from people. So I don't know that it's an open invite for a ton of posts, but

I would agree to allow this one. **Robert Wittkamp** Do we see about limiting the amount. **Ty Van Ryswyk** I'm doing it in the fact that I know where this one is going to go, I'm okay with it. And then if somebody asks for another one, we'll see. I'm wouldn't put a limit of we're going to okay two, we're going to okay five. We will do it case by case. **John Crotty** I would agree with that.

Water Issues on Tamarach (431 & 445)

Rob Clarkson I went out and looked, there was a connection made to our cross-road culvert on both ends of this road. One has failed. Previous homeowner on the outbound side had asked us to provide them some riprap to keep people from falling in the hole that was created by a wash out. The new homeowner bought this problem. It was a connection problem, and it is in our right of way. I think we could go out after bids for this and have a new connection made between the two pipes. They've buried it completely behind these houses all the way to almost Westview, that's not our responsibility. The original house plans was prior to 2019 so we can't do anything about it, it was never approved. I never found any paper-work stating that anything was approved for the inbound side of it where there's a manhole. But that seems to be flowing fine. It might alleviate some of the problem but on a 3" rain in 30 minutes, you're never going to capture all that water. It's just too big of an area and it's a natural drainage. It's a temporary solution to their problem for normal rainfall and it would allow us to be able to clean our culvert.

Jerry Allen So what are you proposing exactly to put in there? **Rob Clarkson**

To have a couple of contractors look at it and build a basin basically that serves as a coupling between the two. They're pipe and ours. A removable grate so we can get in there, but it would alleviate the whole wash out with the missing link in between. The culvert pipe underneath the roads fine, it's the connection that was made however many years ago, how many owners ago that has failed. **Jerry Allen** What do you think the cost would be, just a ballpark figure of the top of your head? **Rob Clarkson** Under \$5000. if I had to guess **Anthony Harrell**

So I don't know if that's going to completely solve this gentleman's problem, but I think it definitely will help. I think it's the right thing to do. Everything that's after that, that does not belong to the Association, I don't know what diameter piping they put in to that runs from that down. There's a lot of water that comes through and if they put in a 16" pipe from that point on their still going to have a restriction and that's going to be up to the homeowners to work out because that's not our property. **Rob Clarkson** Another reason for the grate on top of our connection is so that water can come out and it will go across the ground at that point. **Anthony Harrell** Good point. **John Crotty** Is everybody OK with Rob going to get a couple of bids on this and bringing back the plans and costs. **Shaun**

Diltz Has this area already been ditched? **Rob Clarkson** No. **Shaun Diltz** Is it on a schedule to be? **Rob Clarkson** No. **Shaun Diltz** So we ditched some of that quadrant over there. **Rob Clarkson** We did Tamarack, not High Point. **Anthony Harrell** So that may have contributed a little bit, Shaun, because we did do Tamarack so there's three points of entry on Tamarack, Prairetown, and north and south from Tamarack. So those three come into one point there at Tamarack, and then it flows across the back yards over to High Point. And all that's flowing well and everything that's on the east side of the road flows fine. It's that one restriction right on the other side of the street. **Shaun Diltz** I just know in the past, when we were talking about the ditching, we were going to go from the lake outward, so you didn't end up forcing too much, this kind of looks like what was happening there. But on that Southwest quadrant, a lot of that flows not into the lake, but out towards Prairetown Road. So it looks like right in between is that spot that's flowing back into the lake. **John Crotty** Rob what kind of time frame or you looking at? **Rob Clarkson** I think within a month I could have you something. **John Crotty** We'll add that to the agenda for the last meeting in August.

Water Issues on Tamarack (1610 & 1608)

Rob Clarkson I want up and looked at this one too. The majority of this water that's coming through is actually coming off the farm fields. I can give you some pictures John so you can get an idea. Culvert is plenty big to hold the water, I think the complaint was where the water is going afterwards, which it goes to Su Twan Lake, and the ditch line that leading to Swan Lake. But there's an awful lot of water that comes out the farm field, you can see the scouring on the lawn where the water is flowing. I don't know what you're going to do about water coming off the farm field. It's a natural water flow. Those are concrete streets back there with curbs. So the water goes to the curb and runs down also. **Jerry Allen** So her complaint was from 1608 to 1610. They're on separate sides of the street. And then that water coming in by where it crosses the road on 1608 that's where it backs up? Or was that their complaint? **Rob Clarkson** I don't know how it's backing up. I mean, that's a big culvert pipe going underneath there. I can see a lot of water going through it and it was clean. I mean, there's no debris, I took one twig out. And so I mean, it's flowing. **John Crotty** You're correct. 1608 is on the side towards the farm field, 1610 is on the other side towards Su Twan. **Robert Wittkamp** So the real problem is not the culvert, it's really just the natural way it flows, an unfortunate spot. **Rob Clarkson** You can increase the culvert, you're still going to get that water. **Robert Wittkamp** Would they have better luck trying to talk to the farmer about it possibly since it's actually the farmers property. **Rob Clarkson** Yes, for a drain tile or something. They done it all along the back of Carribean. I don't know who that farmer is over there. **Robert Wittkamp** So the better approach would be to have those members talk to the farmer. **Shaun Diltz** I'm looking at aerial pictures from '83 because I was curious. The water came from that field, you can see it flowing and then cutting actually two spots going into each cove. That's how it was naturally flowing. Same thing it looks like on 1641 a little bit down. Water was hitting that lot pretty good. So it looks like so those are two low spots on that farm field. **Rob Clarkson** Where it crosses the road is actually our outlot. **Jerry Allen** Can you follow up with the homeowner let her know that we've looked at it and make a suggestion to her.

Grants

Rob Clarkson There's been no reply yes or no on our grant. **John Crotty** We have one outstanding right now. **Rob Clarkson** Yes. **Jerry Allen** And who did we send that to Rob? **Rob Clarkson** That is through Madison County for sustainability that was denied but they said there's a possibility that we get it in October. **Shaun Diltz** And from history, that's usually actually what always happened and then we usually got it. **Rob Clarkson** Sometimes we've gotten it. **Jerry Allen** And how much is that grant? **Rob Clarkson** \$15,000, I believe as long as we put forth 20%. **Shaun Diltz** And just from history, that's the one that we typically get compared to all the ones that we apply for because we are private. **Rob Clarkson** And that does make a big difference. I know at the last meeting, there was discussion about Litchfield Lake getting grants for their dredging. It is a municipal lake, it's state. We are considered private, and it makes it much harder.

New Business

Silt Removal Plan

John Crotty I think we one of the things that's on here is determining what to do with the current dredge. I think we need to look at potentially getting rid of it as it does not do what we require at this time. And Rob had some ideas on potentially direct selling it ourselves, or trying to find an auction. Anybody have any ideas? **Anthony Harrell** Wasn't Stutz interested in at one point? **Rob Clarkson** Word was they were, when I talked to him he laughed at me. But one of the guys from Kamadulski said that he's still kicking it. I haven't left him alone. **Jerry Allen** Any idea what the value of that dredge is with all the piping? **Rob Clarkson** I don't know. I was going to try to look up somebody to give me an idea that because I have no idea where to go with it. I was going to call some of these dredgers on the river and see what they thought. **Jerry Allen** Yes, it seems like a pretty special piece of equipment. **Shaun Diltz** I mean, for every day that it sits here, it's losing value. It's rusting and doing whatnot. And it's just going to cost more to get going. As soon as we find someone to get rid of it, to buy it I would be fine. **Anthony Harrell** I'd say we put a timeframe on it, if we don't sell it by a certain point take it to an auction. So Rob, maybe do a little research on what we can maybe get for it and make Kamadulski an offer. **Rob Clarkson** I went on the internet and tried looking it up as the model. I discovered there was only two, that was a prototype and there's no value given for it. The piping is worth some money. **Anthony Harrell** So we can figure out the price of the piping and the couplings. **Rob Clarkson** There's no couplings, it's a fusible pipe. They just butt fuse it. We had someone fuse the dredge for us. I guess that was the most cost-effective pipe that we could buy at the time. **Anthony Harrell** So whatever the price of the piping is, and then figure that out, and then add a few grand for the dredge itself. **Shaun Diltz** Yeah, it doesn't look good if it's a prototype. Parts are going to be tough. And with the fuse piping, that means it's high maintenance to move it around and add pipe and takeaway pipe and whatnot for it so that's all bad news. **Anthony Harrell** It's not that good. **Shaun Diltz** But the sooner we get rid of that, I guess we can continue other paths forward for silt extraction, but I guess that's step one on this list. **Robert Wittkamp** Is there any other small lake around that maybe possibly be interested in it? **Rob Clarkson** We've beat Dunlap to death on it because they've been wanting to do their lake and they have absolutely no interest in it. **Robert Wittkamp** So what we have is something that nobody else wants. **Rob Clarkson** That's the only person I've talked to, to try to talk into buying it because I know they're looking at a means to do their dredging, they have absolutely nothing. And they've got some very high bids to do their dredging over there. **Shaun Diltz** Are we still a member of the ILAC? Have we sent an email out to that group? **Rob Clarkson** I have not, other than Carolyn, which is the manager of Dunlap. **Shaun Diltz** Okay. I would definitely send that just for fun. See if anyone's interested in it or knows anybody that's interested or where they might sell something like this? Yeah, they could probably help us quite a bit, just to tell us where else to put that up for sale. **John Crotty** So I propose that we give Rob about four weeks to do more research and where to get rid of it. If he comes up with something before then bring it to the board as for what for someone to buy, obviously, we can get rid of it. But maybe the last meeting in August, then we will discuss kind of what you found on possibly selling it and we'll make some decisions on what to do with it from there. **Ty Van Ryswyk** Can you send a description of what we have. I do work on every small lake in Southern Illinois, I can hand it to the people I know at those lakes. **Rob Clarkson** Most definitely. **Shaun Diltz** Is the trailer for sale with it. **Rob Clarkson** Yes. **John Crotty** Next items on the list, we'll go into the research and what we do one out here for silt removal. We've talked quite a bit about getting a couple barges with a bucket to remove the silt. The one barge would hold the equipment and the other one would hold the silt as we dig it out. We've talked about wanting to have an idea how much money we have from the dredge and what we have in reserves already and then get an idea of what kind of equipment we can get. So I don't know if we want to move on to the next step of trying to determine what we need or wait till we get this dredge out of here and having a better idea what kind of money we have. **Shaun Diltz** I think we can go to the steps of what we need right now. And from my perspective, on the board, I'd like to see two plans. One that has a barge and some heavy equipment and one that is just waiting every five years for the lake to come down doing parts of the lake that

need it the most. Saving money for a few years or putting a reserve item in, and then tackling that every five years similar to what we did in the back of Spanish Cove. But instead of three days perhaps we get two weeks, three weeks at it. We moved a ton of dirt in three days, imagine doing it for longer and I think that Stutz even mentioned some to you. **Rob Clarkson** Yes, Chris Stutz and I talked about it when we're going over the dam at Su Twan. He said he could clean that entire north end out. It was not an issue. **John Crotty** So does it make more sense for us to have our own equipment and barges, or every five years pay somebody to do a different area of the lake? And then once you dig it out, it's going to last. **Shaun Diltz** Personally, I think you got our own equipment that's going to break down and do what not, you have liability issues, you got people that were going to pay for training and stuff like that, or just hold a bucket of money and then every five years, grab a certain area of the lake, maybe get it into a 30 year cycle, where we're just going and hitting one area every 30 years or every 40 years. And then eventually, we're done with the silt problem. **Robert Wittkamp** It'll also bring up storage issues for all this equipment, where we're going to put it. Who wants to look at it on a lake? **Anthony Harrell** Any areas where Stutz or some other company would not be able to get an excavator into. **Shaun Diltz** That would be part of that plan I would say that we collectively need to look at. **John Crotty** I know we've had a lot of little coves that people dug themselves out this year, and they were able to get people back there. But now whether or not we'd have our lots to get into it. **Anthony Harrell** They drove across their own property. **Shaun Diltz** If you say, Hey, we're digging this section out, so you don't have to sink in mud can we use your backyard? They probably would let that happen. I don't know. I know I would. **Rob Clarkson** I think you're right, I think the majority probably would, because they're benefiting from it. **Shaun Diltz** It's going to raise property value for everyone out here. **Ty Van Ryswyk** And even if there's a spot that Stutz or that type of dredging or silt removals not going to work, there's a company that will have a way to remove that silt in those areas. **Anthony Harrell** Isn't there a company that has barges that actually do silt removal? Up around Springfield I thought. **Rob Clarkson** Just about every dredging company, there's a bunch on the river. **Anthony Harrell** Yeah, we can cross that road when we get to it. **Rob Clarkson** Then you also got to think about bringing somebody else's barge in and what their bringing it in with that barge. **Jerry Allen** What kind of work do we got to do in the meantime, to determine which coves need the most work? **Rob Clarkson** The north end definitely needs the most work. **Jerry Allen** Do we need to set up the coves for a timeline of which one gets finished? **Shaun Diltz** That would be part of that plan I would imagine. **Jerry Allen** And how do we determine which one to go to other than us anecdotally choosing one, because of depth perhaps. **Shaun Diltz** I think we could probably put some rankings on how much silt is in each of these areas, and then you could put priority based on it. That would be kind of one of my guesses. I know a lot of the bass fishermen out here could tell you the areas that need dredged the worst, I guess, because they're the ones that are the shallowest. **Rob Clarkson** The only main influx of water that wasn't touched this year is the north end. **Anthony Harrell** I would think that the ones that have inflow from the

Slow Cooker Macaroni & Cheese

16 ounces elbow pasta
4 tablespoons butter
3 ounces reduced-fat cream
cheese
2 cups whole milk
12 ounces evaporated milk
1/2 cup light sour cream

2 large eggs, beaten
3/4 teaspoon ground mustard
pepper, to taste
8 ounces shredded sharp cheddar
cheese
8 ounces grated provolone
cheese

Cook pasta al dente according to package directions. Drain and pour into large slow cooker.

In small saucepan over medium heat, whisk butter and cream cheese until melted. Stir in milk, evaporated milk and sour cream; whisk until combined. Remove from heat; whisk in eggs, ground mustard and pepper, to taste. Stir in cheeses. Pour mixture over cooked macaroni and stir to combine cheese and pasta.

Cover and cook 2 hours on low. Switch to warm until ready to serve.

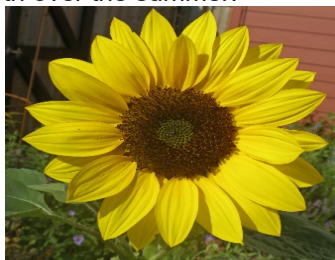

You may be wondering what there is to do in your gardens and landscaping during the month of September.....PLENTY! Listed below are several important chores that you need to consider in order to prepare your gardens for winter to be ready for the beautiful spring flush of color next year.

- **Divide perennials:** 1) To improve the health and longevity of the plant, as division is often what is needed for rejuvenation; 2) To have more plants to transplant to other areas in the landscape; 3) To improve the appearance of a clumping perennial with a "bare spot" in the middle; and 4) To check the spread into areas where they are not wanted. (At this time, do not divide those plants that flower in late summer.)
- **Plant spring flowering bulbs:** Enjoy a bounty of bloom next year by planting bulbs now. Tulips, crocus, daffodils, hyacinths, and other early-bird bloomers can be massed in beds by themselves or tucked in between established perennials and shrubs. Select a variety that will bloom at different times to provide color from early spring through early summer.
- **Improve your soil:** As you remove dead/dying vegetables and flowers, spread a 2"-3" layer of compost/manure and work it into the existing soil for enrichment.
- **Enhance your landscape:** This is a great time to add shrubs and trees to your landscape, and be sure to water them deeply right up until hard frost to ensure survival through the winter.
- **Improve your lawn:** Your lawn will benefit from dethatching, aeration, and fertilization at this time, and don't forget these lawn tools can be rented. September is also an excellent time to seed or sod new lawns.
- **Bring houseplants indoors:** Bring them indoors before frost! Give each plant a cleansing spray from the garden hose, inspect them closely for insect hitchhikers hiding in the foliage, wipe the pots clean on the outside, and prune those that have had too much new growth over the summer.

Firefighter's Footnote

9/11 - Where were you on 9/11 twenty years ago? None of us will ever forget where we were when the twin towers fell and the Pentagon was hit. Or when we found out that a fourth plane had been brought down in Pennsylvania to prevent it from crashing into the White House or Capitol. The terrible images being played out across the screen. A total of 2,977 lives were lost in the attacks: 2,753 people perished in the twin towers, 184 people at the Pentagon, and 40 passengers and crew in the plane that crashed in Shanksville, Pennsylvania. That includes 343 New York City firefighters, 23 New York City police officers, 37 officers at the Port Authority, and 184 Pentagon workers. Many more people have since died due to related health issues who worked at ground zero, either to search for victims or to clear the debris. We will never forget those who lost their lives. Fire Department is grateful to be able to serve our community. We are a volunteer department, as are many of the surrounding fire departments, dedicating our time and honing our skills in case we are needed. Let us mark this 20th anniversary remembering those who died in the attacks. Let us never forget the 343 firefighters that perished on 9/11, and all firefighters who serve - risking their lives to save others. HSFD is hosting a memorial service on Saturday, September 11 starting at 8am. It will be held outside at the Memorial Garden which holds part of a twisted steel beam from one of the fallen towers. This year's ceremony commemorating the 20th anniversary will be a little more elaborate. We will have the Patriot Guard and the Staunton Honor Guard present along with various speakers. Refreshments will be served afterward. You can tour the facility and our trucks as well. We hope you will join us as we pause to reflect

on the fallen 343 firefighters and others who lost their lives in the attacks. Never forget.

- 15 graham crackers, crushed
4 (8 ounce) pkgs. cream cheese
¾ cup milk
1 cup sour cream
¼ cup all-purpose flour
- 2 TBSP Butter, melted

4 eggs
1 TBSP vanilla extract

1 bay leaf

peeled tomatoes (with
liquid), roughly chopped
- 1 ½ cups minced clams,

Heat oil in a large pot over medium heat. Add the onion, garlic, celery and crushed red pepper and cook, covered, stirring occasionally, until soft, about 8 minutes.
Stir in tomato paste and cook, stirring, for about 1 minute more. Tie the parsley sprigs, fresh thyme, and bay leaf together with a piece of kitchen twine and add to the pot with the potatoes. Pour in the clam juice and bring to a boil. Lower the heat and simmer, covered, until potatoes are tender, about 10 minutes. Stir in the tomatoes and clams. Cover and bring to a low simmer. Season with pepper to taste. Divide among warm soup bowls and sprinkle with parsley. Serve Immediately.

fields that you got are going to be the priority. Like the ones down on Shore Drive where you have municipal streets running in, that's not going to have as much silt build up as you would from the farm fields. **Shaun Diltz** You're right. **Rob Clarkson** Stutz did the entire back of Turtle Cove, it's a main influx that's coming from a farm field, across Prairetown Road, and the farm fields off of Fountainbleu. They both come in at that area and they dug all that out this year, and it was six foot deep. I couldn't put my trolling motor down in there prior to that, they gained 4' back there. It's not the first time it's been done, though. **Shaun Diltz** But we've put some riprap into that inflow since that, haven't we? So we should have caught quite a bit of silt the last five years compared to the first 50. **Rob Clarkson** I would agree with you. **Jerry Allen** I guess my real question is, do we need some expert to help us determine. We all know the north end is a priority. But I mean, all the other areas that we might not be thinking about. **Rob Clarkson** We have lake committee that did a silt study years ago, and we could reach out to them and see if they would want to do that again. I don't want to say it wasn't accurate, but it's not accurate today for what we have. **John Crotty** Do we feel what's going on the north end can wait another five years. **Shaun Diltz** I would be ecstatic to know that in five years, it will be complete. Just in general, I would rather have one big swoop. I don't know how much more expensive it would be for the barge versus the other thing or if one's cheaper than the other. **Rob Clarkson** The only thing with the barges is you're moving it twice. **Shaun Diltz** So it's more expensive. It shouldn't be silting up as much as it used to because they've done a lot of work. In with that grant that Rob is even talking about most of that work was done on the north end. That's why the lakes cleaner, honestly, and that's why there's more algae blooms because the sun's reaching deeper than it used to. If it was muddier the sun wouldn't be able to reach and then there wouldn't be algae blooms. **Ty Van Ryswyk** Well, maybe I don't understand the barge thing exactly how it would work. But to me, like Shawn saying, just knowing that it's going to happen in three to four years, five years when it drops, would mean as much to me as somebody going out there and starting to do something. And it also comes back to the fact of just like, shutting down an interstate and getting it done in three months versus closing one lane and getting it done in four years. I mean, if we wait a little bit, dropped the lake and they can do it in a short stint and be done, I think is worth a lot. **Shaun Diltz** Jerry I can get some pictures. I've mapped a lot of the bottom of this lake anyways. I haven't mapped the silt, but I've mapped depths. And we can do some guessti-

mates based on some of this stuff. I think we can get pretty close to give an accurate representation on what there is out there. I like the idea of having a lake committee look at it as well. I can definitely hand it off to them. Rob, how deep did we go in the back of Spanish Cove. **Rob Clarkson** So we went eight feet deep and that's when we hit hardpan. And to my knowledge that has never been touched. **John Crotty** So I think that takes us back to being able to have an idea of money and how much we would have each five years to spend over say a 30-year rotation. We need to sell the dredger and see what we have in reserves for the dredger and this that we could turn into reserves for silt. **Shaun Diltz** We have about \$85,000 right now in reserves today for the dredger and the dredge trailer. **Anthony Harrell** So the three days that Stutz was able to dig into the main entrance there, what was the value of that? **Rob Clarkson** We paid \$15,000 for 300 tandem loads to be pulled out of there. It wasn't Stutz, just for the record. **Anthony Harrell** So the transportation costs were what killed us, right? **Rob Clarkson** Yes, transportation costs \$100 an hour for one truck. **Shaun Diltz** Just getting the silt from there over to there. **Rob Clarkson** Yes to the north end, which should be a lot shorter haul if we're doing the north end, if we're still talking about the north end. **Anthony Harrell** But now with the barges we eliminate that transportation cost, right. **Rob Clarkson** It opens it up to a whole bunch of different contractors to that would have their own trucks and not have to job it out like the other guy did. So that's approximately 100 loads a day, which was 1500 cubic yards a day. \$5,000 a day. Just that one little simple example \$5,000 a day. **Anthony Harrell** We're going to have a lot more at that north then what we did, right here. **Shaun Diltz** But this first five year go at it, we might have an influx based on barge sale and reserve. **Rob Clarkson** We don't know where hardpan is there either. **Shaun Diltz** Well, I was told by Angelkey when I was up there one day that they didn't dig that to hard pan when they filled the lake up. So it was just green pasture when the lake started filling. So I don't know if you're going to be digging silt and topsoil at the same time, I guess we can probably decide how deep we're going to go. I don't know the difference. I've never dug into that before. **Rob Clarkson** Hardpan is easy to see. **Jerry Allen** On the north end, I'm thinking of just the distance from where the water hits the road right there close to it out to where the buoy is that says No Wake. Will we be able to get that whole area or would it be able to get further into the lake by doing it once every five years. **Rob Clarkson** You would have to stop 50 feet from the pipeline that goes through there, which is the second or third house from the end. You can't dig within 50 feet of that. So we'll have a hump in the middle, but it will slug out once that flow gets in there. **John Crotty** Well, I think we have a plan as of right now for four weeks from now, Rob, to give us an update on the sale of the dredger. If he gets some sooner he'll reach out to us, so we can discuss it. So we'll rediscuss it, looks like our next step really is getting the dredger out of here. Obviously, if we're looking at not doing something for five years, we've got a little time to get this plan in place. **Jerry Theodore (1346)** I want to mention if you're serious about this, by law you can't get on any other roads other than ours. So if you have to get on to St. James, or Prairetown, or the Dam Road, you'll have to put that in a sealed container to haul it. So you got that expense to add to it. Because you can't get to the north property from every place around the lake without getting on township roads. **Shaun Diltz** I would expect the contractor that would be doing that would take that into account. **Jerry Theodore (1346)** Yes, but the reason I mentioned it is it's an expense you'll have to pay for. One individual out here that I know, got a price to dig out behind when we first authorized the barges on the lake the first time, he got a price. And when you pay to get the barge brought in and removed and he had to also haul on public roads. For his area just basically behind his house it was somewhere between \$25 and \$35,000. Now, that's a small job. And I'm sure you're going to get a better price, probably per yard then he got. We have a method of checking the silt with a two-pipe system of plastic pipe and a pipe within it. You put the big pipe down until it hits the silt, and then you push the other pipe down through the silt and then we got it graduated and it tells you how many feet of silt you got. That was done a few years ago at all the problem areas and there's probably some records on that somewhere. But I don't know how valid that is today. **Shaun Diltz** I was actually looking forward to doing something similar to that this winter while it was iced over. But it never was safe enough to walk on.

Public Safety Proposal

John Crotty Rob has a proposal to the board for a code enforcement officer that would help look at some of the code violations that we have out here in the Association area outside of the lake and on the lake. **Rob Clarkson** The thought behind it was as hard as it is to have public safety all the time especially today when nobody really wants to work. And they're just part time kids basically, having somebody part time during the day to basically drive the community daily. Help out with the permitting aspect of things with the communication for the builders and whatnot so we don't run into some of the scenarios that we run into in the office with you know, "I didn't know". Granted we give them a packet and they are responsible to read that packet, but having somebody there to, just like any other inspector if you were working for the county or something, they give you a punch list. And then deal with the tallgrass. We don't really do house watches and stuff anymore; we do get calls for them. We encourage everybody to call Madison County, because they'll actually get out of their vehicle, check your doors, it gets them in our community. Our kids are armed with a flashlight. It's a danger to them. It is more of a liability to the Association to have them get out and try to check somebody's house, so we don't do that anymore. I think maybe keep a couple for boat patrols and have this one person, I think you could save some money on it. It's just a thought, an idea that was running through my head, thought I would bring it up to you. **Anthony Harrell** You see that being a full time or part time? **Rob Clarkson** I think there's enough work, it could be full time. **Anthony Harrell** Sounds like it with all the permits. **Rob Clarkson** I think you reach out and see what you get, and whether they want to do it part time or full time. I mean, preferably, I'd rather have a part time guy, honestly, I mean, save us more money. Preferable I'd like to have somebody from the community. **Jerry Allen** So you see this person as being basically the supervisor over the remaining public safety staff we have? **Rob Clarkson** No, I think you would cut your public safety basically, to seasonal. We really don't need them for the ballroom stuff, if it's just letting somebody in or letting somebody out we could do an electronic lock on the door with a code. They let themselves in and out, you can change that code. I see the means of public safety going by the wayside in today's day and age, for what we do with public safety I should say. **John Crotty** So when you say seasonal, we would just have a couple purely on the lake. **Rob Clarkson** Just like we do with lifeguards. Hire them for boating season. **Anthony Harrell** Then we have somebody on the lake all the time, all summer. **Rob Clarkson** I mean, this guy could do it as well as you know, off season. Or this person I should say, I hate to use a gender. **Jerry Allen** But you don't see them having any supervisory role in this at all. Just being a code enforcement officer. **Rob Clarkson** No, they would answer either to myself or Rob Frey. **Anthony Harrell** I think it's a great idea. **John Crotty** The hours for this person, would they be just a nine to five or would we get them here in some evenings? **Rob Clarkson** I think they could probably come close to building their own schedule if it worked out right. I wouldn't say they have to be here Monday thru Friday. **Anthony Harrell** You set a minimum number of hours they need to be here. **Rob Clarkson** Depending on workload, you know how many permits we have out. Obviously, you get into your draw down year there's a lot more, you know, but typically, there's 70-80 permits a year. **John Crotty** Do we have an idea how many calls on the public safety phone after the office is closed? And what kind of topics are getting called on? Because at this point the membership wouldn't have anybody to call if this person was not there. What kind of calls are they getting? **Rob Clarkson** The majority of our calls are noise, which deals with animals and music. And then you know, somebody around their house which we don't answer that. **Robert Wittkamp** I don't call public safety. If I have an issue I call Madison County. **Rob Clarkson** We do have some residents out here that still think it is the old security and that's been gone for a long time now. Just thought, something for you guys to chew on. **Shaun Diltz** I like the idea of having a specialized person for that because with the amount of turnover, they just, like you said they don't know the rules that we have. It's not like we have a ton of rules but, you know, the interpretation, just the understanding and the retention of the rules are difficult to do and use as an enforcement type person for it for the safety purpose. So if there was a more specialized role, then that would be his expectation. It would be a lot easier to hold that role accountable for certain things that are happening. **Rob Clarkson** And it would be one interpretation. **Shaun Diltz**

Unless it's being appealed, and then there'll be a hearing for it. **Rob Clarkson** Exactly. **Anthony Harrell** And then we get security on the on the water all day, during the summer. **Rob Clarkson** That'd be an option. **Anthony Harrell** So I think it's a win win. **John Crotty** Is there any thoughts from those in attendance from the members? Any thoughts out there if we had no public safety, and we just had a code enforcement officer. **Joe Roth (1030)** I'm really glad I came to this meeting, I didn't realize we didn't have security anymore. **Rob Clarkson** Public Safety for the last numerous years. It even says it on the truck, Joe. **Joe Roth (1030)** I'm living in Oregon more than I thought. So we don't have basically any rules out here. **Rob Clarkson** Oh, we have rules. **Jerry Theodore (1346)** But we don't have anybody to enforce them. **Rob Clarkson** We have college students for the most part. **Joe Roth (1030)** Well, why don't we have anybody on the water? Why would you have security on the water that does not, in fact I've heard people laugh about it, that does not have any enforcement power at all? Can they write a ticket? **John Crotty** Yes, for the rules on our lake. **Joe Roth (1030)** Wow, this is exciting to me. I don't think most of my neighbors even know that. I'll have to them come to board meeting, I guess. Thank you. **John Crotty** And I guess I'd ask the board that then, as that's probably the case for a lot of members. What's the best way to maybe possibly get more feedback on this idea before we would move forward on it? Because I think a lot of people do think that there's still security out there, they still call it security. **Jerry Allen** Probably need to put something on our website or Facebook that kind of summarizes what we have now and what we come up with as far as a code enforcement officer and what they do, so they can see the differences right now. And the issues we're running into such as not having people continue to work, they come and go as they please as far as taking the job or leaving the job. So having somebody to really enforce the rules much harder than what they have been. I think most people would like that. They just need to understand where we are now and also where we want to go. So I would think we need to show them so of the job responsibilities we would want this person to do and follow up with it. It's that first step anyway for them to understand what we're talking about. **Shaun Diltz** Definitely, this is something that you keep on old business on the minutes for a while, just so it recycles its way through the minutes and gives the community a chance to sit on it and come up and talk. **Ty Van Ryswyk** I would agree with that getting it in the minutes so people can read it. They would have to come to the meetings to discuss it obviously, but I think it is a decent idea getting a legitimate person to do code enforcement and watch over our Association. I also think a part of this would be along with putting this in the minutes as getting people to understand if they have real issues that they need to call Madison County because we just don't have security, they're not allowed to do certain things and a lot of that is for the better of the Association. We don't want a college kid with a flashlight getting into a domestic dispute or in a fight with a dog or anybody. So the decisions that have been made with public safety in the past have been for a benefit and I think looking at this is beneficial as well, times change. **John Crotty** What I'm hearing is maybe one, we want to make sure this gets out to the minutes. So this particular one won't be out for at least till it is approved till the next meeting. Potentially may write up something that could go on Facebook and maybe even in the Times that says, Hey, members, here's where we are today, here is where we're thinking about going to, give us your input. Come to a meeting and so we can hear your input. **Rob Clarkson** I agree with that. **John Crotty** I can I work with Rob on writing up something and sharing with you guys and make sure it sounds right and we'll try to get it in the next Times and on the Facebook page. And since we probably won't have a lot of people, maybe we'll get a few of those rumors out there and hearing it coming up next meeting. So we'll have it on, but we'll assume the big talk won't come until we start seeing the minutes and it gets out to the public, so probably won't be till say a month from now before we really start seeing people possibly show up. Thank you Rob for the proposal, I think it's something definitely worth looking at. **Rob Clarkson** The deadline for The Holiday Times is the 10th.

How to Help Manage Pet Separation Anxiety

For more than a year, working from home and keeping social circles small due to COVID-19 has meant people have been able to spend more time with their pets. However, as more Americans are vaccinated and restrictions loosen across the country, it's likely many are spending less time at home with their pets. How to Identify Separation Anxiety

Changes in behavior are some of the most common indicators of separation anxiety. These behaviors are coping mechanisms and can include excessive barking or whining, destruction near exit points or windows, having accidents around the house, hyper salivating, pacing, decreased appetite and depression. To better understand what your pet is experiencing, consider setting up a video camera when you leave to see how he or she behaves when you're not there.

Ways to Prepare Your Pet for Separation

Unpredictability has been shown to add stress for many animals, including dogs, Coppola said. Routines, however, can help many pets cope with stressful situations. Because a vacation or long weekend getaway involves a change in your pet's routine, these seemingly small changes can make him or her susceptible to separation anxiety. If you know change is coming, slowly introduce your pet to the idea of being alone beforehand to help your four-legged friend prepare. Start by taking short trips outside your home without your pet - even if just for a few minutes - and consider leaving treats or toys to help make the alone time more enjoyable.

When you are ready to leave the house, set up a cozy, inviting space for your pet, where he or she can't destroy items or get hurt trying to escape. Consider a non-carpeted area in case of accidents or install a doggie door to allow for going outside when necessary. Prior to any period of alone time, mentally and physically engaging your pet by going for a walk or run, or working on quick trick training, can make it more likely he or she spends at least some of the time you're gone resting.

While you're gone, Coppola recommends providing your pets with enrichment activities such as puzzles, chews and calming aids like the Adaptil Calm On-the-Go Dog Collar. Calming vests like the veterinarian-recommended Thundershirt can also help pets transition.

Solutions for Coping with Anxiety

If your pet is excessively barking or exhibiting destructive behaviors, never punish him or her and avoid expressing disappointment or frustration, Coppola said. It is understandable to feel this way, but it can upset your pet further and add to the stress he or she may already be feeling. Instead, spend time having fun together when you are home and consider an option like PetSmart's Doggie Day Camp, which can help ease the transition by gradually introducing your pet to the amount of time left alone. And I've spent 20 years, we owned an island up on the 222 mile marker on the river and I'm very familiar with barges and rocks and gravel and how much you need to get in there. You couldn't put a barge on this lake and load it down to be economical to float it because a steel barge weighs a lot. When you put mud and water on it, it weighs a lot more. Okay, the second thing is John, you guys call it the concrete cove. Okay. they dredged that three times. They got it six feet deep. And four months later, it was three feet deep. The reason was the hard pan that goes by Ty's house and goes down is only three feet deep. And that is the bottom line. You can't push mud uphill. Brittany and Biscay, you're all familiar how that road floods. All good topsoil washes down, goes under the road and goes in that concrete cove and it's a mess, so it's three feet deep. So remember that when you want to dredge, remember at the north end, the problem with the lake the is that the silt is pretty, pretty bad. But the hardpan is very shallow. I've lived here 47 years gentlemen, I've seen boards good and bad. I've saw board members good and bad and I've seen the same mistakes every 10 years come up. But think about that when you want that barge in here, how much it's going to weigh, how much water you're going to drag and how you're going to move it. Okay on with my speech. Thank you. Thank you to Rob. We were going to, my daughter insisted on us moving to Florida, we're both in poor health. Gloria is 76, I'm 77. We've had some major health issues. And she even went as far as to have the house appraised so we can move down there. I went to a class with Rob, which is has nothing to do with Holiday Shores, it was a firearms class. And I didn't know he was going, he didn't know I was going and I mentioned it to him. I haven't saw him since. I was out cutting grass and he stops and starts a conversation about the class and I know he wanted to know why we were still here. Well, the bottom line is that he's doing a great job. I'm very, very impressed that he would have enough time to stop and ask me. And the board's doing, even though you guys scare me when you talk about some of this stuff you're doing one hell of a job. Thank you. Our property values are up, our roads, this is not West County. I am very happy with the roads. I lived here 47 years and I've saw them throw down

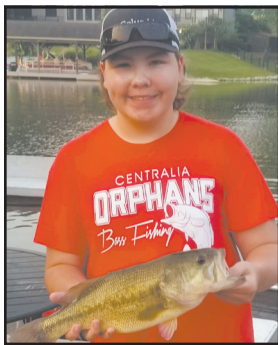

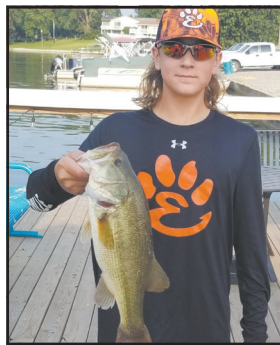

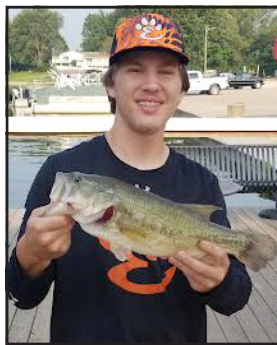

Joe Roth (1030) I do have a comment and a concern about our lake water. I go out there every morning and it is the worst I've ever seen it on this lake, I mean, it is pathetically green and stuffs just swarming over the bottom of it. What's going on? **Rob Clarkson** You're going to get more algae blooms, because the water is clear the sunlight gets deeper into the water now and allows it to grow more.
