Manager's Report by Rob Clarkson



The 75' and No-Wake buoys are in place to protect persons and properties. These are not merely suggestions and are remaining to be strictly enforced. The definition of wake is outlined in our Boating Rules and I would encourage everyone to give these rules a look over and ensure your guests know them as well. The fishing arm of our lake is always No Wake. As a reminder if you have been issued a citation relating to boating you are required to take the Holiday Shores boating test, and passing, before operating your watercraft again.

Road surface renewal is scheduled for first week in September. If your road will be part of the plan this year you will receive a notice asking that you refrain from parking on the roadway that day. We are working repairs in a systematic order so please be patient and understand we have limited manpower to accomplish this task while taking care of all the other amenities of Holiday Shores.

Holiday Shores is a restricted title community. Present and future owners are bound by these Instruments. I would encourage everyone to read these as we have seen a higher number of Signage, Permit, and Boating violations recently. If you are new and do not know where to get a copy you can access them online at www.holidayshores.us or simply stop by the Office and we will get you a copy.

We are starting to see Algae blooms this year and the maintenance crew has been out working to keep our water free of this nuisance. Many use fertilizers on their lawns and with the abundance of rain we have encountered this year much of that fertilizer makes its way to our lake. The geese and ducks are constantly adding another source of food for the algae growth. A conscious effort by all when applying fertilizers (stay 25' from water edge) or disposing of yard waste correctly (not in lake) will help a great deal.

BEACH AND SWIM SAFETY

Holiday Shores Regulations

1. Beaches located within the Association are restricted to members and guests only.
2. Glass bottles, fires, pets and food are prohibited from the beach area.
3. Persons under the age of 16 are allowed to swim: if being escorted by an individual 17 years of age or older or there is a lifeguard on duty.
4. During each shift, a lifeguard is allowed a ten-minute break every hour, during that time, swimmers under 17 years of age must exit the water, if not with an adult.
5. Holishor Association Inc. is not responsible for one's personal items, nor any personal injury sustained while using Association facilities. (water, beach, grounds, etc.)

IL Dept. of Public Health Regulations

1. Beach water is not intended, nor fit, for human consumption. Do not swallow beach water.
2. Beach admittance may be denied to individuals having:
 - Contagious diseases
 - Infections (foot infections, ear infections, vomiting, diarrhea, inflamed eyes, unhealed abrasions or lacerations, skin lesions, or bandages of any kind.
3. Persons under the influence of alcohol or behaving erratically will be denied access/removed from the beach.
4. No food, drink, gum or tobacco products are permitted in the swim area.
5. The use of glass containers is strictly prohibited.
6. Children who are not toilet trained must wear tight fitting plasticized/rubber swim pants.
7. Swimming alone is discouraged.
8. Diving in shallow water is prohibited.
9. Personal conduct that endangers the safety of ones' self, or other beach patrons, is strictly prohibited.
10. Swimming is permitted between sunrise and sunset, except during the times of thunder and/or lightening. Swimmers are required to exit the water during these conditions and remain out for a minimum of 30 minutes following the last detection of thunder or lightning.
11. Pets are prohibited from the beach area.
12. Beach patrons are not permitted to feed local wildlife or entice them to stay in the area. Wildlife harassment is also strictly prohibited.
13. Measures taken to protect ones' self from the sun, such as sunblock, beach umbrellas, etc. are strongly recommended.

Su Twan Dam Repair

Rob Clarkson The repairs on Su Twan Dam were completed on Friday June 4th. The water level was dropped an additional 24" to relieve more pressure. Visible tunnels were present in the face of the dam which appeared to be consistent with muskrat activity. Bentonite was mixed with the soil and activated then returned to the excavated area and compacted. The site restoration of seed and straw has been completed as well. We will allow the lake to fill naturally with the upcoming rain events.

New Business

Dam Inspection

John Crotty We have a bid for the dam inspection that is inspected every 3 years. Crawford, Murphy & Tilley will have a two-engineer team that will perform the field inspection looking at the earth embankment, drop spillway, three conduits for the auxiliary spillway, abutments, and downstream channel. The Association will provide any repairs made to the dam since the previous inspection three years ago. A report will be prepared and submitted to the Association and IDNR. The bid is for \$6,300.

The Holiday Shores Ski Club request the permission of the BOD to use the lake and property at the north end of the lake for show practices and water ski clinics, beginning the first Saturday in May. We would like permission to anchor the ski jump in the north end no wake area and the option to pull it out and temporarily anchor it for practice. The ski club also requests assistance from the lake patrol in limiting boat traffic at the clubhouse during the dress rehearsal practice on July 2 from 6pm-8:30pm and for the July 4 ski show from noon to 3pm. The ski club thanks the Holishor BOD for the fantastic support of the club over the years.

Henry Halverson (1829) I'm the president of the ski club and I'm here to answer your questions as it pertains to the requests or any other grievances regarding the ski beach and playground in that area. With regard to the playground up there, I don't know when it was agreed upon that the club would maintain it but as I mentioned to Rob last year, the ski club is really kind of a two month out of the year activity. In my opinion, if we as the ski club are required to maintain it, it's probably not going to get maintained so it should probably be removed. **Ty Van Ryswyk** Living straight across from it I would agree that it is not used. **Dave Decker (1184)** If I recall correctly, I'm pretty sure that was actually put in at the request of the ski club and at the time the board agreed to put in, as long as the ski club maintained it. **Henry Halverson (1829)** And that may very well be, I'm sure Dave has his facts correct so that's why I say if this is a community amenity, we probably shouldn't rely on the ski club to take care of it. If it's a ski club entity the members haven't shown any interest in maintaining it then just get rid of it. I would also like to ask; I know that there was an issue last time we had the ski show with the fire department. I don't know if the Association needs the Fire Department there for some reason but I don't think the ski club really needs the fire department there. We have practice down there every week, sometimes two or three times a week, we don't have the fire department, EMS or anything like that. I guess there was confusion between us and the office as far as who coordinates with the fire department. **Anthony Harrell** When I was in charge of safety for the ski club I took care of arranging it. **Henry Halverson (1829)** That's fine we'll call. **Shaun Diltz** I understand there was a member ran off the lake at the north property for fishing from a kayak. **Rob Clarkson** Yes, you can not fish, swim in that lake. **Dave Decker (1184)** I believe that rule was passed for safety reasons. Conversation ensues. **Tony Harris** I think we should leave the rule as is for now. **Kurt Take (667)** Asked if possible to add bumpers to the clubhouse docks. **Tony Harris** We can look into the cost to put something up. **Rob Clarkson** Will have cost for the next board meeting. **Robert Wittkamp** I can get a firehose for free. **Shaun Diltz** The dock is set for repairs in 2024.

John Crotty I was informed that it may be a stretch for the restaurant to be able to make their July 4th proposed opening due to delay of delivery of kitchen components.

ZUCCHINI-PEPPER SKILLET WITH TOMATOES AND GARLIC

1 pound zucchini (about 4 small)
2 cloves of garlic, OR one teaspoon minced garlic
1 onion, thinly sliced
1 tsp. salt (optional)
1 (28 ounce) can diced tomatoes, OR
two 14.5 -ounce cans tomatoes
¼ tsp. Pepper or to taste
¼ cup parmesan cheese or to taste
2 Tablespoons Olive Oil
Sprigs of Parsley to taste (optional)
1 small green pepper, diced
½ Cup Mozzarella Cheese
1 small yellow or red pepper, diced



Prepare zucchini into ¼ inch slices. Cook and stir zucchini, onion, peppers, oil, garlic, salt and pepper in 10-inch skillet until heated through. Cover and cook over medium heat, stirring

occasionally, until vegetables are crisp tender, about 5 minutes. Add tomatoes. Cover and cook over low heat just until tomatoes are heated through, about 3 minutes. Sprinkle with grated parmesan cheese, snipped parsley and mozzarella cheese.

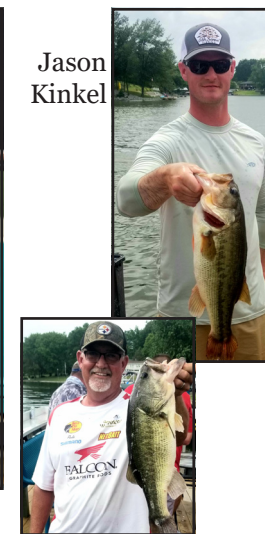

BOATING SAFETY

Legal Compliance – “All watercraft operated on Holishor Association Lakes must adhere to and comply with state and federal laws as stated in the Illinois Registration and Safety Act.”

Speed Limit – “The maximum speed of any watercraft operated on Holiday Lake shall be 55mph or as defined in the Reckless or Careless Operation section of the Holiday Shores Boating Rules. Operation of said watercraft shall be in a manner that does not create an exaggerated wake. Intentionally ‘plowing’ or ‘pushing water’ at speeds greater than no-wake, but less than those typically maintained while ‘on plane’ is not permitted.”

Watercraft/Registration – “All watercraft being operated on Holiday and Su Twan Lakes must have a current state registration decal and numbers, one/current Holiday Shores decal, and lot numbers affixed.”

Operating Age – The minimum age to operate watercraft on Holiday Lake is 12, providing the individual has passed a state certified boater safety class. Individuals between the ages of 12 and 18 must possess a valid boater safety card to operate watercraft, unless under the direct supervision of a member or a person over the age of 18, who has member consent.

Watercraft Limit – No member shall have more than three motorized watercraft registered to the same membership in operation at one time.

Size Limit – All watercraft being operated on Holiday Lake except pontoon boats with tubular bottoms, are limited to 22 feet in length. Pontoons are restricted to 28 feet.

Traffic Pattern – All watercraft being operated on Holiday Lake must follow a counterclockwise direction of travel, similar to that of operating a motor vehicle on the roadway.

Boating Hours – Boating on Holiday and Su Twan Lakes is permitted 24 hours a day, but watercraft are restricted to No-Wake speeds from sunset to sunrise.

Noise Level Limit – No watercraft may be operated on Holiday or Su Twan Lakes in a manner that exceeds a noise level of 75 decibels. This restriction includes inboard/outboard motors, stereos, etc.

Restricted Areas – No watercraft shall be operated in any manner except prescribed for areas marked No-Wake, Swimming Area, etc. Holiday Lake is considered No-Wake when the lake reaches 9” above full pool and 16” below full pool.

Reckless or Careless Operation – Careless: No watercraft shall be operated in a manner that puts any person or property in danger or at a rate of speed that prohibits the driver from stopping the craft within a safe distance. Reckless: No watercraft shall be operated in a manner that willfully and wantonly puts life, limb, or property of another person in danger. This restriction applies to actions such as weaving through traffic, jumping wake when visibility is obstructed, following too close to skiers, playing ‘chicken’, or passing another craft in a manner that produces a hazardous wake/wash. This restriction also applies to the misuse of water skis, wake boards, or other devices.

Water Skiing – Water skiers, wake boarders, tubers, etc. may not be towed without at least two competent persons in the tow boat, to observe the individual(s) being towed and provide assistance if distressed/injured.

Distance – Operators must keep a safe and reasonable distance between their craft and other lake users, such as swimmers, downed skiers, fishermen, etc. They must also maintain a distance of 75ft from shore when making a wake. Seventy-five-foot markers have been replaced with new, larger white/blue buoys.

Orange Flag – Operators are required to display a bright orange flag on their vessel **any time they have a skier, tuber, wake boarder, etc. in the water.** The flag must be a 12 inch by 12 inch square and affixed to the highest point of the craft, such as a ski tower or pontoon top.

Racing – Racing of any watercraft on Holiday or Su Twan Lakes is prohibited.

Power Turns – Power Turns (also referred to as 180s or 360s) are permitted as long as the following criteria are met: 1.) Craft is not unreasonably close to another craft, causing it to swerve or take evasive action to avoid a collision. 2.) Not done in a manner that causes the driver and/or passengers to be thrown from the craft. 3.) Not done in a cove or in a manner which causes a nuisance to another member.

Engine Cut-Off – All watercraft (prop-driven and PWC’s) equipped with an engine cut-off device may not be operated unless the device is properly functioning and it’s lanyard is securely attached to the driver.

PERSONAL FLOTATION DEVICES

PLEASE READ THE IMPORTANT INFORMATION BELOW REGARDING PERSONAL FLOTATION DEVICES. IT IS IMPERATIVE THAT THE APPROPRIATE PFD IS KEPT ON EACH WATERCRAFT WHILE BOATING ON HOLIDAY LAKE AND SU TWAN LAKE. THIS INFORMATION CAN BE FOUND ON PAGES 9 AND 10 IN YOUR HOLIDAY SHORES BOATING RULES.

Personal Flotation Devices from 625 ILCS 45/4 1 No person may operate a watercraft unless at least one U.S. Coast Guard approved PFD of the following types or their equivalent is on board for each person: Type I, Type II or Type III. No person may operate a personal watercraft or specialty prop craft unless each person aboard is wearing a Type I, Type II, Type III or Type V PFD approved by the United States Coast Guard. No person may operate a watercraft 16 feet or more in length, except a canoe or kayak, unless at least one Type IV U.S. Coast Guard approved PFD or its equivalent is on board in addition to the PFD's required in paragraph A of this Section. A U.S. Coast Guard approved Type V personal flotation device may be carried in lieu of the Type I, II, III or IV personal flotation device required in this Section, if the Type V personal flotation device is approved for the activity in which it is being used. When assisting a person on water skis, aquaplane or similar device, there must be one U.S. Coast Guard approved PFD on board the watercraft for each person being assisted or towed or worn by the person being assisted or towed. No person may operate a watercraft unless each device required by this Section is: Readily accessible; in serviceable condition; of the appropriate size for the person for whom it is intended; and legibly marked with the U.S. Coast Guard approval number. Approved personal flotation devices are defined as follows:

- Type I A Type I personal flotation device is an approved device designed to turn an unconscious person in the water from a face downward position to a vertical or slightly backward position and to have more than 20 pounds of buoyancy.
- Type II A Type II personal flotation device is an approved device designed to turn an unconscious person in the water from a face downward position to a vertical or slightly backward position and to have at least 15 1/2 pounds of buoyancy.
- Type III A Type III personal flotation device is an approved device designed to keep a conscious person in a vertical or slightly backward position and to have at least 15 1/2 pounds of buoyancy.
- Type IV A Type IV personal flotation device is an approved device designed to be thrown to a person in the water and not worn. It is designed to have at least 16 1/2 pounds of buoyancy.
- Type V A Type V personal flotation device is an approved device for restricted use and is acceptable only when used in the activity for which it is approved.

No person may operate a watercraft under 26 feet in length unless a Type I, Type II, Type III, or Type V personal flotation device is being properly worn by each person under the age of 13 on board the watercraft at all times in which the watercraft is underway; however, this requirement shall not apply to persons who are below decks or in totally enclosed cabin spaces. The provisions of this subsection I shall not apply to a person operating a watercraft on private property.

Further, no person may operate a watercraft on Holiday or Su Twan lakes unless a Type I, Type II, Type III, or Type V personal flotation device is being properly worn by each person under the age of 13 on board the watercraft at all times in which the watercraft is underway.
